Oral Arguments Heard in South Dakota's Challenge to Quill

On August 29, oral arguments were held in *South Dakota v. Wayfair, Inc. S.D.*, No. 28160, which



challenges the state's remote sales tax legislation, S.B. 106. Enacted during March 2016, S.B. 106 requires remote sellers to collect and remit tax to the state - even if they have no physical presence in the state - if they have more than \$100,000 in sales or make more than 200 separate sales into South Dakota annually.
